<p>Please indicate below the dates you are requesting for your show and indicate what type of show (i.e.: pleasure and/or contesting). Also, if requesting multiple show dates please clearly indicate that. Clubs or organizations holding annual point shows on or about certain dates shall be granted first opportunity for approval of show date each succeeding year by the OWHA Show Approval Application to the OWHA Show Committee by February 1. If you do not submit your OWHA Show Approval Application to the OWHA Show Committee by February 1, then those dates and all other open weekends will be open to the first applicant. The Board of Trustees shall resolve conflict between organizations as to show dates.</p>

Show Fees
<p>Show Fees are \$45 for one day show or \$55 for a 2 day show. After receiving an invoice from OWHA, these fees must be paid and received by the OWHA Show Committee on March 1, 2008, or we cannot reserve your show date. The definition of a one day show is: (1) Speed classes only (min. 5 OWHA approved speed classes or more) is a one day show. (2) Pleasure classes only (min. 15 OWHA approved pleasure classes or more, must include (4) Pony classes and (3) 8 &amp; under classes) is a one day show. (3) Combination of Speed and Pleasure Classes on the same day or Speed and Pleasure classes offered consecutive days is a one day show (This includes the min. 15 OWHA approved pleasure classes and the min. 5 OWHA approved speed classes as stated in Item #1 and #2 above). (4) Anything outside of this definition is a two day show.</p>

Show Committee Information
1. Show Committee's must submit their tentative show bill to the OWHA Show Committee for review by March 1.
2. After OWHA Show Approval Committee returns the final draft of your tentative show bill to you, the Show Committee must submit their final show bill to OWHA 90 days prior to your show in order to guarantee input into our newsletter and website.
3. If you are conducting a OWHA Pleasure show, the show bill must include 15 or more of the OWHA approved pleasure classes, which must include 4 OWHA Pony Classes and 3 OWHA Small Fry Classes.
4. If you are conducting a OWHA Contesting show, the show bill must include 5 or more of the OWHA approved contest classes.
